Resolved, that it is expedient to provide that from and after the 1st day of July (1885), all fish imported shall be chargeable with, and there shall be collected thereon, the following rates of duty, viz: :	
Mackerel	1 cent per lb.
Herring, pickled or salted, ¼ "	" "
Salmon	1 " "
Foreign caught fish imported otherwise than in barrels, or half-barrels, whether fresh, dried, salted or pickled, not specially enumerated or provided for by this Act

Anchovies and Sardines, packed in oil or otherwise, in tin boxes measuring not more than five inches long, four inches wide and three and one-half inches deep, five cents the whole box; in half-boxes measuring not more than five inches long, four inches wide and one and five-eighths deep, two and a half cents each; and in quarter boxes measuring not more than four inches and three-quarters long, three and one-half inches wide, and one and a quarter deep, two cents each.
