

**ORDERS, ETC.—Con.**

On *County Ct. Judges'* removal B., in Com., *Mr. Power's* Amt. for payment of costs to a Judge when acquitted on enquiry, objected to by *Mr. Dickey & Sir A. Campbell*, as involving expenditures, & withdn., 93-4.

On *Mr. Read's* Res. of advisability of *Dom. Debentures* being placed within respective Provinces, *Sir A. Campbell* pointed out (but not as a ques. of Order) the inexpediency of the Senate adopting a Res. which, affecting Finance policy, could not be authoritative, 142.

MOTION, *not according to Notice*; point raised by *Mr. Power*, Great Eastern Ry. Bill, 594.

ORDER; *Personal*.—*Mr. Alexander* desiring to make a personal statement, on 2° of Deceased Wife's Sister Marriage B., & being called to order, *m. the adjournment* for the purpose. Objection taken (*Mr. Dickey*) that it was not competent for him to interrupt the progress of the Order of the Day for that purpose, 220. (See "Privilege," below.)

*Mr. Botsford* having spoken to the M. of conc. in Amts. of Com. (St. John's Bridge Co. B.) his m. to re-com. the B. was objected to, (*Mr. Bellerose*); objection sustained by the Speaker, 426.

*Mr. Haythorne* speaking on Inqy. (*Mr. Wark*) and *Sir A. Campbell's* Reply, on Irish Emigration, *Mr. Vidal* raised the point that there was no Ques. before the House. *Mr. McClellan* claimed the custom of discussion in such cases; and made further remarks on the subject. 662.
