STREET RAILWAY CHANGE.

The London South belt line instead of going north on Richmond, will go east on Dundas around Central Avenue, the balance of the line in London South remaining as usual.

MR. ATKINS**NOW ON THE HEIGHTS!**

First Detachment of Soldiers Arrived Today.

Preparations Made for the Main Body, Which Comes Tomorrow—First Camp 1,500 Strong—List of Staff Officers.

The year's silence upon Carling's Heights was broken yesterday by the noise of tent building, and now for a month a camp ground at Wolsely Barracks will be the center of local activity. This was a day of quiet completion of final details and of preparation for the morning, when the regiments walk in. Only five corps will be in London the first couple of weeks: The First Hussars of London (Major Strothers), the 26th Regiment of Middlesex (Lieut.-Col. McEwen), the 27th of Lambton (Lieut.-Col. Weir), and the 33rd of Huron (Lieut.-Col. Varcoe). The Bruce men were the first to have representatives on the field, their detachment for tent-building have arrived quite early in the morning. They went to the heights immediately and prepared for their regiment's reception. Other men detailed for the same purpose came to the city later in the day.

It is to be hoped, for the sake of the men in camp particularly, that such weather as we enjoy today may continue. Rain at camp time is the bane of Atkins' life, and excessive heat is nearly as disagreeable. The utmost care will be taken this year to make the camp thoroughly sanitary. The prevalence of smallpox necessitates unusual precaution, and Principal Medical Officer Belton will do all that is possible in this respect. This morning he inspected the barracks and found it in the same state of cleanliness and order that excited the admiration and praise of Gen. O'Grady Haley upon his late visit here.

Among the officers, non-commissioned officers and men who will come to camp this year will be many who served in South Africa, and the practical experience that they gained during the campaign will doubtless have its effect upon the camp regarding its layout, the drill, and the methods of instruction. Major Denison, C.M.G., who was on Earl Roberts' staff, and Capt. Carpenter, of the first regiment, will be in camp, and Sergeant Price, Sergeant Turt, Sergeant Bethune, Sergeant Holmes, Corp. Horner, Ptes. Merrick, McCubbin, Monroe, Miles and Shaw, all members of No. 1 Company, R. C. R. I., will be on duty, several of them on the staff of non-commissioned officers.

The staff of officers for the first brigade will be Lieut.-Col. Peters, D.O.C., brigadier; Major Denison, C.M.G., brigade major; Lieut.-Col. Regier, D.A.A.G.; Lieut.-Col. Young, instructor of musketry; Lieut.-Col. Dawson, paymaster; Major Belton, principal medical officer; Veterinary-Lieutenant Wilson, veterinary officer.

Police Court Proceedings.

Robert Blackwell, an ex-soldier, was released from jail on Saturday. He spent the afternoon in the pursuit of acquiring a jag, and on Saturday evening he was acting in a disorderly manner on King street, when he was arrested by P. C. Donahue. In the cells at the police station, Blackwell got into an altercation with a fellow inmate, an Indian, who has been in jail several times. Williams is small, but a bad Indian, and Blackwell now carries a good-sized stick. The police magistrate thought he needed time to sober up, and gave him 21 days in jail.

The case of Simon Levi, charged with assault by his wife, was further adjourned for a week. The charge of assault laid by James Murphy against Wm. Fogarty was withdrawn on the large paying the costs.

Albert Lloyd pleaded guilty to using abusive language toward a fellow workman, Frank Wood, and paid \$2 fine and \$5 costs.

Two citizens charged with leaving animals on the streets promised not to offend again, and were let go, while three Indians who imported too much firewater were also discharged.

PROPERTY TRANSFERS

Real Estate Valued at \$325,000 Changed Hands Here Since January 1.

In the first five months of the new century an unusually large number of property transfers were made in this city, nearly 200 having been recorded between January 1 and May 31. The value of the property that changed hands amounted to more than \$325,000, and the selling prices ranged from \$1, the legalized gift price, to \$25,000.

The New York Mail and Express says that under the title of the American Shirt and Collar Company a \$20,000,000 then goods manufacturers trust will be incorporated under the laws of New York State.

ALLIES SHOT EACH OTHER

Serious Affray at Tien Tsin—A Frenchman Killed and Others Wounded.

Tien Tsin, June 3.—There was a serious affray yesterday between international troops. Some British Fusiliers who were acting as police here, and preventing French soldiers from house-breaking, were attacked with bayonets and bricks. The fusiliers responded by firing into the air. This brought a number of Germans to the aid of the Frenchmen. They numbered together 200 men. Five Fusiliers fired again, this time killing a Frenchman and wounding three others. In subsequent fighting four Fusiliers, five Germans and one Japanese were wounded. The arrival of a German officer and a strong guard ended the fray.

COUNTY COUNCIL

BEGIN BUSINESS

Warden Trafford Campbell's Opening Address.

The Middlesex county council assembled yesterday afternoon for the June sessions. The members present were: Warden Trafford Campbell, Councillors Peter Elson, John Bradley, Geo. Neely, James Murray, Alex. Gray, A. King Hodgins, Simon McLeod, R. W. Jackson, R. M. Piper, Harry Gough, J. W. Salmon, J. P. Grigg and D. D. Graham. The absentees were G. D. Robotham and G. B. Campbell.

After the reading of the minutes, Warden Campbell delivered his opening address. He expressed his pleasure at seeing the councillors ready for the transaction of their duties, and said he did not doubt the other members of the council were especially pleased to see present Councillor Simon McLeod, of Parkhill, who was prevented by illness from being present at the last session of the council. He briefly reviewed the business to come before the council and reported on certain matters which has been referred to him for action. In answer to the letter of condolence forwarded to the King, a letter had been received from Capt. Harry Graham, A. D. C., to the governor-general, expressing his sympathy.

The reading and referring to committee of communications was then proceeded with.

CAPITAL NOTES

Mr. G. W. Dawson, ex-M.P., Appointed Inspector at Penangguishene—George Taylor, Bothwell, To Be Magistrate at White Horse.

Ottawa, June 3.—At a cabinet meeting this morning an order was passed appointing G. W. Dawson, ex-M. P., and recently Liberal organizer for the Province of Ontario, to be inspector of penitentiaries at a salary of \$2,400.

George Taylor, barrister, Bothwell, has also been appointed magistrate at White Horse in the Yukon.

NON-JURY ASSIZES ARE IN PROGRESS

First Case Settled and One Now Being Heard.

The non-jury sittings of the spring assizes opened yesterday at the court-house. Only six cases are on the docket. Owing to the serious illness of Judge Ferguson's daughter, Chief Justice Meredith is taking the sitting.

The first case on the docket, that of Corp. vs. North American Assurance Company, an action to have declared illegal and void the cancellation of plaintiffs' insurance policy by the defendant company, was settled out of court by the defendants paying plaintiff a sum in excess of the payments made by him on his policy. R. K. Cowan, plaintiff, and J. E. Davidson, Patterson and Grant, Toronto, for defendants.

The second case was taken up, it being the Provincial Chemical Works, of St. Louis, Mo., vs. Canada Chemical Company, of London, an action to restrain defendants from using a registered trade mark, "A. P.," as applied to preparations of acid phosphate of lime manufactured by both companies, and used in the manufacture of baking powder. The witnesses for the plaintiffs are Chas. J. Young, secretary of the company, and Messrs. McLaren (Hamilton), Fuller (Brantford), and Ewing (Montreal), baking powder miners. The witnesses for the defendants are Prof. Harrison, Prof. James Bowman and Mr. John Bowman. Walter Cassels, K.C., Toronto, and Cronyn & Betts, Toronto, for the plaintiff, and George F. Shepley, K.C., Toronto, and George F. Flock for the defendants.

LOOKING FOR BETTER TERMS

A Number of Ottawa Mechanics on Strike.

Machine Wood Workers and the Carpenters Those Who Have Gone Out—The Labor Situation Elsewhere.

Ottawa, June 3.—The strike fever has struck Ottawa today. One hundred machine wood workers went on strike for a 20 per cent increase in wages. The firms affected are the Ottawa Car Company, 25 men; Thackeray & Davidson, 30; and the W. C. Edwards Company, 40. The men demand recognition of their union, as well as increases. Attempts to settle the matter amicably failed, as the employers would not consider any increases nor would they treat with the union.

The carpenters of the city are also on strike for 25 cents an hour, minimum wage. Many of the men get from 17 to 20 cents an hour, and some get 25, and an effort is being made to get the larger amount. Some of the men tell the employers who are paying a few men 25 cents an hour say that the others are not worth it, and they refuse to pay the same rate to all. The carpenters first tried to get an amicable settlement, but failed.

The 35 tinmiths who went out on Saturday still have no settlement. The woodworkers' strike is spreading, and about 200 men are now affected. The morning of the tinmiths' strike is this morning at their headquarters. The employers will meet tonight to discuss the situation. They say it will kill business to grant the men's demands. All the men are orderly, and no trouble is feared.

ADVANCE CONCEDED.

Wilmington, Del., June 3.—The Betts Machine Company and the Standard Machine Company, employing about 75 men, have granted the nine-hour day with ten hours' pay to the striking machinists. The men returned to work today.

Buffalo, June 1.—Four hundred and fifty men employed in the New York Central car shops at Depew went out on strike this morning. Between 350 and 400 of them are machinists, and the rest are machinists' helpers.

BRICKLAYERS STRIKE.

Toronto, June 3.—About 40 bricklayers' laborers went out on strike Saturday for an increase in wages from 18½ cents an hour to 21 cents. This is only about one-third of the bricklayers' laborers employed here.

THE MACHINISTS' CONVENTION.

Toronto, June 3.—The delegates to the national convention of the International Association of Machinists, which opens this morning in St. Andrew's Hall, were continually arriving in the city Saturday and yesterday.

After the reading of the minutes, President O'Connell considered very satisfactory. Mr. W. Melican, president of District No. 8 of the International Association, arrived in the city last night from Chicago to confer with Mr. O'Connell in regard to the situation there.

"I am informed by Mr. Melican," said President O'Connell to the Globe, "that the situation in Chicago is not so bad as it is reported to be. It is only a matter of time before the men will go out at any time to assist the machinists. Their assistance, however, is not considered needed at the present juncture. If a general strike occurs it will involve 25,000 people."

"Mr. Chalmers, a large foundryman of Chicago, and practically the mouthpiece of the metal trades in that city, said that the Metal Trades Association propose to return to the tool and die makers' strike."

Mr. Chalmers said the ten hours have gone forever, and he will never be able to secure that system again."

ACTION WAS ILL-ADVISED.

The action of the men in the New York Central car shops at Depew, who went out, will have to be discussed by the convention, as their action under the rules of the association was illegal.

"It was an ill-adviced action," said President O'Connell referring to the matter, "very much so."

CONCILIATORY.

The Betts Machinery Company, of Wilmington, have offered a nine-hour day and 10 per cent increase in wages, to the employees of the paper mills. In the meantime they offer to pay overtime for the extra hour, and a settlement will probably be made on that basis.

Tolyoke, Mass., June 3.—Two thousand employees of the paper mills in this city went out on strike Saturday afternoon, as ordered by the Eagle Lodge of Papermakers' and the Stationary Firemen's Unions.

MORE CONCESSIONS.

Hartford, Conn.—Eighteen hundred of the men who have been on strike here returned to work in six machine shops this morning, the companies having granted the demands for a nine-hour day with 10 hours' pay, while agreeing to recognize local shop committees, but not the union's committee.

Youngstown, Ohio.—The National Tube Company of the United States Steel Corporation today voluntarily advanced the wages of the 425 workers in the Youngstown plant an average of 17½ cents per day.

Newport News, Va.—About 800 machinists struck today at the Newport News shipyard.

TWO MONTHS FOR YOUTHFUL THIEF.

Samuel Betts Sentenced on Two Charges of Stealing.

Samuel Betts, the Lucan lad who pleaded guilty to two charges, one of stealing \$15 from his employer, Chas. Avey, of Biddulph, and the other of stealing and selling a gold ring belonging to Wesley Charlton, of London township, was brought before Judge Edward Elliott yesterday.

He was sentenced to two months' imprisonment on each charge, the sentences to run concurrently. In passing sentence, the judge referred to the fact that the boy had started as early on a career of crime, and warned him that unless he mended his ways he would probably spend a large portion of his life in prison. There had been only one offense, said the judge, he would have been disposed to let the prisoner go on suspended sentence. Even as it was, he proposed to make the punishment a lenient one, and would accordingly recommend that the boy be not taken to the Central Prison, where he would consort with abandoned criminals, but be allowed to serve two months in the county jail.

SOCIETY WEDDING

Marriage of Miss Frances Lilian Dignam and Sir Jean Alexander Van Hoogenhouck Tulleken.

Toronto, June 3.—Four Toronto brides were married on Saturday. One of these was Miss Frances Lilian Dignam, daughter of Mr. and Mrs. J. S. Dignam, of St. George street, whose marriage with Sir Jean Alexander van Hoogenhouck Tulleken, first lieutenant Royal Guards, The Hague, took place at half-past two o'clock in the drawing-room of her home in the presence of the relatives and a few intimate friends only. The ceremony was performed by the Rev. George Davey.

There were no bridesmaids, nor groomsmen, and the witnesses who signed their marriage certificate, which was bound in a handsome "bridal book," were the mayor of Toronto and the consul of the Netherlands, Mr. A. Nordheimer. From 3 until half-past four o'clock a stream of friends arrived to offer their congratulations. The guests were received upon their entrance by Mr. and Mrs. Dignam, and then passed on to offer their congratulations and good wishes to the bride and bridegroom, who stood under the arch of white lilies in the bow window of the drawing-room. FOOTBALL.

CANADA VS. ENGLAND.

Montreal, June 3.—There is every chance of an "all Canada Rugby team" going to England next fall to show the English football players what sort of men there are in Canada, and the matter will come up for final consideration at the meeting of the Quebec Rugby Union which will be held in Montreal on Saturday, June 8.

Many of the older players in this vicinity are greatly in favor of such a trip, and if it should be decided to send a team it is certain that a large number of men would turn out to practice the English game, which was seen here at the time of the visit of the Irish team.

That there is an earnest endeavor to bring about such a trip is shown by the extensive correspondence which has already passed between England and Canada upon the subject. If the plan carries the present differences of opinion between Ottawa city and the remainder of the Quebec Rugby Union will probably be smoothed over, and players from Ottawa as well as from Montreal will figure on the international team.

FOUND DEAD IN BED.

Vankleek Hill, Ont., June 3.—D. N. McLeod, merchant tailor, was found dead in bed at his boarding house this morning. He was single and aged about 30 years. His parents reside in Dunvegan.

DR. UNGER ADMITTED TO BAIL.

Chicago, June 3.—Dr. A. M. Unger, on trial for alleged conspiracy to swindle insurance companies which had written policies on the life of Mary Diefenbach, was admitted to bail Saturday in the sum of \$15,000.

ICEBERGS IN OCEAN HIGHWAYS.

St. Johns, Nfld., June 2.—The Allan Line steamer Sicilian, from Glasgow, which arrived here yesterday, and an upper-carrying steamer arriving at Tilt Cove, both report immense ice floes 200 miles off the coast, drifting south into the track of trans-Atlantic shipping. The floes are studded with great icebergs, which are particularly dangerous to ocean steamers.

GEN. BALLINGTON BOOTH'S STATEMENT.
