#### SUGAR FOR CANNING PURPOSES

## Mr. CRUICKSHANK:

1. What amount of sugar for canning purposes has been allotted per individual in each rural and urban ration centre in Canada?

2. What was the average amount of sugar used per housewife for canning purposes in each of the years 1939, 1940, 1941 and 1942?

3. Upon whose advice was the amount set in rationing of sugar for canning purposes in rural and urban districts this year?

4. What experience has such person or persons

in practical canning?

5. Were women's organizations consulted? If so, which of them?

#### Mr. ABBOTT:

1. Sugar for canning purposes was allotted to the various local ration boards on the basis of 11.34 pounds per applicant.

2. The average amount of sugar used per housewife for canning purposes in 1939, 1940 and 1941 is not available. According to statistics prepared by the ration administration, 106,179,000 pounds were used for home canning purposes during 1942.

3. The home canning programme was decided upon after discussions between the sugar administration, the foods administration, the consumer branch, the ration administration of the wartime prices and trade board and the Department of Agriculture.

4. The questions to be decided related to sugar distribution and the mechanics of rationing, rather than the method of canning.

5. The foods administration, the ration administration, the consumer branch of the wartime prices and trade board and the consumer branch of the Department of Agriculture each had a woman representative attending these discussions.
