**Hon. Eric W. Kierans (Postmaster General and Minister of Communications):** We have handled all requests from the Legion in the same manner as requests from other associations. There is a very modest increase in the annual fee, sometimes 30 cents, sometimes 40 cents; and as was mentioned yesterday, 27 cents a year would recover all the increased postal charges.

SHORTAGE OF AIR TRAFFIC CONTROLLERS
