FREE DENTAL SERVICE FOR INDIANS

Question No. 1,574-Mr. Burton:

- 1. Are people of Indian origin entitled to free health services for the extraction of teeth and, if so, on what basis is this service provided?
- 2. Are people of Indian origin entitled to free service for filling of teeth or work on dentures and, if so, on what basis is this service provided?
- 3. If there is any difference in the service provided in Parts 1 and 2, what is the rationale for such differences?

Hon. John C. Munro (Minister of National Health and Welfare): 1 and 2. Not by treaty or statute. The federal government has always taken the position that responsibility for health lies in this order: (a) With the individual; (b) With his group; (c) Within the provincial programs.

Only when these three resources fail to meet requirements does the federal government become involved. This position is supported by the fact that traditionally and constitutionally health care services have been the responsibility of the provinces for all residents within each province.

Many of these people of Indian origin, however, either live in isolated areas or are indigent and thus are unable to obtain or pay for dental or medical attention in the ordinary way. Each year Parliament appropriates a certain sum of money for the provision of public health and essential dental and medical care for this group. To ensure that funds are used for the purpose intended, it is necessary to establish certain cri'eria concerning the acceptability of individuals for assistance, and to place certain limits upon those services which medical services is prepared to approve.

The acceptability of any individual is governed by the following conditions: 1. A patient must be listed on a Register for an Indian Agency; 2. The patient must be medically/ dentally indigent, or so isolated that the costs of transportation associated with procuring necessary treatment would place such care beyond normal economic means; 3. No other Agency, e.g., Provincial, D.V.A., Workmen's Compensation Board, Insurance, etc., has responsibility for payment of the account; been or are being considered.

Hon. E. J. Benson (Minister of Finance): 4. When an Indian has established residence palities for their own use and not for resale. ty for a period long enough to qualify him for assistance from a Provincial, Municipal or any other organization, he generally ceases to be acceptable for assistance from Medical Services.

> The objective of the Indian Health Program is to provide or arrange for health services for eligible Indians in order to assist them in achieving a standard of health comparable to that of other provincial residents. Indian groups are, in most provinces, receiving the same benefits under hospital and medicare plans as all other citizens. Where special needs above and beyond what provincial programs provide are required, the federal government endeavours to augment provincial services.
