I believe I indicated to him in the House at that time that details would be in members' offices within the next day or so. I find that because of the problem of getting the regulations to the regional offices across the country, this information will not be in the hands of members until some time later this week. However, the regulations are being relaxed on a flexible basis, giving more flexibility to the regional managers. We are also co-ordinating, with the provinces, a comprehensive program so that the sometimes arbitrary restrictions, where they do occur, will be removed.

ADVERTISEMENT RESPECTING USE OF POSTAL CODE

This ad shows a bare-bottomed woman in a string bikini mailing a letter, with an old man painting the postal code on her rear end. The ad bears the following inscription:

We're not "stringing" you along
Use postal codes—you'll "thing" our "thong"
Don't be cheeky—you've all got 'em
Please include them on the bottom

This ad carried the logo and official sponsorship of Canada Post. In view of the blatant sexism of this ad and the insult to Canadian women, indeed to all Canadians, and in view of the fact that it is the Canadian taxpayers who will be called upon to pay for this sexist garbage, will the minister assure the House that those responsible in the Post Office for approving this ad will now also be held responsible for the payment of the cost of the ad and no government payment will be made?

Hon. Bryce Mackasey (Postmaster General): Mr. Speaker, I can assure the hon. member that I found this ad offensive. I consider it an insult to the women of Canada. I expressed this opinion rather forcibly in the Post Office some months ago. If the hon. member looks at the date of the ad, he will see that it was published some time ago. The ad will be paid for by the Post Office, but I apologize on behalf of those who inserted it in the press club publication in Toronto several months ago.
