CROWN CORPORATIONS

ELDORADO NUCLEAR LTD.—APPOINTMENT OF AUDITORS— MOTION UNDER S.O. 43

The Minister of Energy, Mines and Resources has stated in the House that he agrees with Eldorado Nuclear Ltd. to replace the Auditor General with private auditors. Since this would restrict the power of Parliament and do away with integrated auditing principles for Crown corporations, I move, seconded by the hon. member for Mississauga South (Mr. Blenkarn):

That this House direct the Minister of Energy to reconsider his approval of the order in council appointing private auditors for Eldorado Nuclear Ltd.
