DECOMMISSIONING OF LIGHTHOUSES—REQUEST FOR INQUIRY

Mr. Ray Skelly (Comox—Powell River): Mr. Speaker, I have the honour to present to the House a petition from a number of residents of the coast of British Columbia urging that the House redress a very serious grievance concerning the removal of staff from lighthouses on the coast of British Columbia. The petitioners point out that this will in fact create a danger to air transportation and marine transportation on

the coast of B.C. and urge the Minister of Transport (Mr. Mazankowski) to call a public inquiry into the matter.

USE OF PENSION INCOME IN CALCULATION OF UI BENEFITS

#### RIDEAU HALL—PUBLIC'S ACCESS TO GROUNDS

Area residents and visitors to the National Capital Region are asking the Government and Parliament to change the decision to close the grounds to the general public, so that there will be further consultations with a group of citizens representing the large and growing opposition to the closing of the grounds in order to find a modus vivendi that will both cope with security measures and the freedom of access to those green spaces.

### PROPOSED CONSTRUCTION IN BYWARD MARKET

Mr. Jean-Robert Gauthier (Ottawa—Vanier): Mr. Speaker, I also have some 60 petitions signed by over 1,500 people from my riding and visitors to the Byward Market, the primary heritage area and tourist attraction in my riding. The petitioners are asking, since the City of Ottawa is considering a proposal to construct a 17-storey building in the heart of the Byward Market, since the National Capital Commission is an agent of Parliament and major actor and property owner in the Byward Market, and since we have invested millions of dollars in the properties in the Byward Market, the House of Commons and Parliament assembled to ask the National Capital Commission to state its position for or against the above development and the proposed constrution.
