GOODS AND SERVICES TAX

Mr. Nelson A. Riis (Kamloops): Mr. Speaker, I have two petitions to present today. One is on behalf of a number of people from the province of British Columbia who point out that with the goods and services tax it will mean that Canada is one of the very few countries of the world that will levy taxes on literature, reading material, religious tracts, children's story books, and the like. In a world where we are attempting to use every means at our disposal to reduce the high levels of illiteracy, it seems to me and certainly to the petitioners that this is a very regressive step.
