PEACE SPEECHES ENGLISH CORRESPONDENTS NOW ASSERT JAPANESE READY TO SETTLE

Russia May Retain Portion of Sakhalin by Re-Purchase in Lieu of Indemnity—This is Said to Be Roosevelt's Solution of Problem—Conference Postponed Until This Morning

Portsmouth, N.H., Aug. 22.—(2 a.m.) It is stated that Baron Kogura at the session of 9:30 o'clock this morning agreed to offer the president's compromise proposition.

London, Aug. 22.—The Morning Post, which during the war has strongly identified itself with the Japanese side, in a despatch from its correspondent at Portsmouth, published this morning, declares that "the peace of Portsmouth is within measurable distance."

The correspondent asserts that both sides will make substantial concessions for the sake of peace. Russia, he says, will pay Japan a sum in the guise of a loan for the maintenance of prisoners of war, and that Sakhalin will be divided. Japan the southern part, while Japan will abandon her claim as to international waters and the limitation of the Russian navy force in the Pacific.

Apparently, says the correspondent, the basis of this settlement is the Russian offer by Russia of a portion of the island of Sakhalin in consideration of a payment of money in lieu of indemnity.
