the Governor to the said Legislative Assembly during the Session in which such Vote, Resolution, or Bill shall be passed.

Provided always, and be it enacted. That the foregoing Provisions of this Act shall have no Force or Effect until the Fiftieth, Fifty-first, Fifty-second, Fifty-third, Fifty-fourth, Effty-fifth, Fifty-sixth, and Fifty-seventh Sections of the Act of the Parliament of the United Kingdom of Great Britain and Ireland, intituled "An Act to re-ningle the Provinces of Upper and Lower Canada, and for the Government of Canada," and the Schedules referred to in the said Sections, shall have been repealed.
