HOW TO OBTAIN A PATENT.

First select a patent attorney of good standing who possesses the necessary facilities, ability and experience. The best man will not generally charge the lowest fee, but it will be cheaper for you to pay a good attorney a high fee, than to pay a small fee to one who will not, cannot or does not render you the very best service obtainable. The strength of, and title to, a patent mainly depends on the manner in which the specification and drawings are prepared. Badly prepared papers may give away the most meritorious invention and render the patent valueless.

Never on any account attempt to do the work yourself, it will not pay you.

Send to your patent attorney a model or sample of your invention. Also (if possible) a few brief notes pointing out the features which you consider new, and the advantages the invention possesses over other known devices. If the invention is a process or chemical composition, state the various steps in the process in proper order, or the ingredients of the composition in their proper proportions. If the invention is a machine, utensil, or the like, you may send, if you prefer, the article itself; it can be returned to you.

If you cannot conveniently send either a model, sample, or full-sized article, send a drawing, or plain free-hand sketches, or photographs, with explanatory notes,

of the invention. Remember you must put him in possession of full information, so that he can understand your invention fully and readily and without having to guess or speculate upon what you may or may not mean. He must understand the invention properly before he can make a clear drawing, or write a full and plain specification and set out in the claim all (and not more) than you are entitled to.

Send your model or sample by Express, charges fully prepaid, properly addressed and marked "Patent Model." Small models may be sent conveniently and cheaply by mail. In sending instructions, state plainly your name in full (middle name included), also occupation and address. State also what you desire to be done and send a fee. If you enclose bank bills, be sure and register your letter. You can also remit by bank draft, accepted cheque payable at par, Post Office Order, or Express Order. You may also send money by Express, and, if in a hurry, by telegraph. Never enclose money with model.

If you are doubtful whether your invention is new, have a preliminary examination made. For this a fee is required, but the payment of this fee may save you a larger useless expenditure. A preliminary examination is, however, not an absolute safeguard, as pending applications and caveats are not open to inspection, and publications and public use cannot

be counted on with certainty.

Should you decide to dispense with the preliminary examination, state in what country or countries you desire to patent the invention and send a retainer fee for each patent. On receipt of your fee with instructions, your attorney will enter the case on his books and send you a receipt on the same day. Your retainer will not be returned. Your case will be taken up in the order in which it is entered and the papers sent to you for signature. The balance of fees must be paid when returning papers, or before filing case in the Patent Office.

A patent may be wholly or partly assigned before its issue, and issued to the assignee, or jointly to the inventor and assignee or assignees. Assignments require to be recorded in the Patent Office, otherwise they are of no legal effect.

The following is the cost of a patent in an ordinary case, *ie.* one that does not require more than one sheet of drawings and a corresponding length of specification, or extra skill and labor in preparation or prosecution, or both. Government fees are included.
