REQUEST FOR STATEMENT ON GRAIN PRODUCTION GOALS

On the orders of the day:

Mr. E. Nasserden (Rosthern): Mr. Speaker, I have a question for the Minister of Agriculture. A week or ten days ago I asked the minister whether he would issue a statement regarding an outline of the goals for grain production in western Canada. Is the minister now prepared to do this?

Hon. J. J. Greene (Minister of Agriculture): Mr. Speaker, I believe this question properly should go to the Minister of Finance, who is responsible for the Canadian Wheat Board. However, I would point out that the farmers can be relied upon pretty well to make their own intelligent decisions in this regard. This I think is shown in the statement of planting intentions issued by the Dominion Bureau of Statistics for March 16, which indicates that western farmers intend to seed 29.1 million acres of wheat in 1966 as compared to 27.7 million acres in 1965, together with an increase of 26 per cent in fertilizer used this year and a 6 per cent cut-back in summer fallow.

If weather conditions are suitable and these intentions are carried out I would expect that we should harvest a crop which would adequately meet our commercial as well as our aid requirements.

Mr. Nasserden: Mr. Speaker, I thought perhaps the minister might have a reply of his own as well.

Mr. W. H. Jorgenson (Provencher): Is it not true, Mr. Speaker, that during the election campaign the members of the government indicated they were going to provide such forecasts on which farmers would be able to base their estimates?

CANADA ASSISTANCE PLAN

INQUIRY AS TO INTRODUCTION OF LEGISLATION
