Northern Railway Co. of Canada:

1. **BILL No. 76.** To remove doubts as to the true construction of Section 12 of the Northern Railway Company Act, 1877. Read first time and Rule 51 suspended in relation thereto. Mr. McCarthy, 202. Read the second time and referred to *Com.* on Railways, etc, 224. Bill withdrawn; Fee refunded, 412.

2. **ADDRESS,** Return of By-laws of the Northern Railway Co., respecting the tolls of said Company since 1st June, 1879, etc. Mr. McCarthy, 121.

North-West Colonization Land Co.:—Bill No. 74. Mr. Schultz, 196. Read second time, and referred to *Com.* on Miscellaneous Private Bills, 266. Reported amended, 309.
