

## THEY WANT'S HOME JUST HAVE HELP

Campaign to Raise \$200,000  
to Aid Homeless, Protes-  
tant Children  
Suggested.

A vigorous campaign to raise \$200,000 for the Homeless, Protestant Children's Home, and the Homeless, Protestant Children's Home, will be conducted in the near future and unless the money is obtained the institution will be closed and the buildings offered for sale.

During the past year there has been an average of 108 inmates and a competent staff of nurses and the contributions have not equaled the necessities by \$200,000. It is said that a large amount of this overdraw was caused by improvements to the buildings, but there are so many applications that it has been found imperative to greatly increase again during the coming months. Unless this is possible the ladies who have taken upon themselves the responsibility of the work, state that it would be better to turn the work over to others.

The Roman Catholics have a similar institution and some fifty young children have been turned over to their care during the past twelve months, and it is considered better to leave the work entirely in their hands if the Protestants of Toronto do not care sufficiently to look after Protestant children to contribute a little to their care and keep.

The annual meeting of the institution was held yesterday afternoon, at which his worship the mayor presided. Doctor Hastings, J. S. Wilson, R. S. Hudson, Amedeus Jarvis, Dr. D. MacGillivray, Rev. Vickers and others spoke. The great subject under consideration was how to wipe off the debt and to raise sufficient funds to put the work on a proper basis. A committee was finally decided upon to take charge of this task and it is believed that a campaign similar to that carried on by the Y.M.C.A. a year and a half ago will be entered upon. It is now 34 years since the institution was opened and no enlargement had been made since that time. Toronto's population is now six times what it was then and the institution made to the infirmaries have increased accordingly.

As a last resort the executive may make application to the government for support. Whether the government would be willing to aid in the carrying on of the work is very doubtful in the minds of some of the workers.

**DIAZ'S VIEW OF NICARAGUA'S NEED.**

The message of Don Adolfo Diaz, president of Nicaragua, in which he commended the impending treaty with the country to the National Assembly, has been published in pamphlet form in English.

President Diaz paints a very unpleasant picture of Nicaragua's poverty and weakness. He says a great part of the blame for this upon the Zelaya administration, which, "unversed in administration," "did not understand the situation of the country," and "how to improve it." Since this unpopular government could be upheld only by the army which could be kept together only by money, it is impossible, he says, to tell where such a government would have landed the country if providence had not decreed the fall of Zelaya regime by means of the revolution of 1909.

The Zelaya administration is described as bent upon destroying the "very sources of national and private wealth." Property was destroyed "with the object of inflicting injury upon the adversary." The system of monopolies and concessions to foreigners and favorites is heavily scored.

The evils resulting from this regime are specified: "the excessive circulation of notes which must be redeemed at a just and reasonable price," the claims of the Nicaraguans for damages, and "the claims arising from the cancellation of monopolies and concessions." The liberalization of the country is also mentioned.

It is President Diaz's opinion, as assuredly a correct one, that Nicaragua cannot correct these evils without negotiating a foreign loan. Two alternatives are presented. One is to wait until the slow action of time has restored things to their natural state before rehabilitating the country. This seems impossible because "opposing interests and passions are disinclined to allow the country to enjoy repose."

The other is to accept the co-operation of the United States, whose bankers will loan the needed money provided that suitable guarantees are given for the security of the loan. In other words, the United States will exercise a vigilant supervision of the customs houses.

President Diaz commended this plan to the National Assembly in no less slender terms than the means of the country's salvation. He expresses complete confidence in the sincerity of this government. He has no fear that the sovereignty and independence of Nicaragua are endangered. He points to the friendly relations existing between the United States and Nicaragua. He cites the case of Cuba and Santo Domingo as experiences that will be repeated in Nicaragua if the protection of the United States is secured.

"If, thru the operation of inevitable social laws, strange influences, which safeguard our independence, which maintain our order and liberty more certain, are bound to enter into our public existence," he concluded, "it is wise, in my judgment, to submit to such a political influence, as it will, doubtless, conduct us to the fundamental organization of republican liberty, which is our most sincere aspiration."
