KEIR Reg. No. C/042, ex-C/M Jessie Fyfe Dorward Keir, 79, died March 19, 1996, at Ottawa. She was born December 4, 1916, at Glasgow, Scotland and joined the Force July 23, 1956, as a civilian employee, at Ottawa, becoming a civilian member April 1, 1960. Keir served at Headquarters until retiring to pension December 4, 1976.

KIRKBY Reg. No. 11888, ex-Cpl. Alfred Lynden Kirkby, 85, died January 6, 1996, at Duncan, British Columbia.
