## Extension Riots

## Reviewed in Court

(Continued from Page 1)

houses, the crowd being about fifty yards distant from Angelo's bunch. Sean Dominick was at Extension on Aug. 19th working in the mine. Was trouble at Extension in the morning. Joe Angelo and two other men were walking around, Angelo hearing the conversation among the other people about the property they were going to destroy. Witness saw one man named Ben and Bill Dominick with Angelo. Home of, witness and all inside was burned. Witness saw E. Morris carrying a gun. Spent the night in the bush about two miles from Extension.

In reply to Mr. Darling witness stated he first saw Angelo about 6 o'clock in the morning and saw him again about 6 o'clock in the evening.

James White informed the Court he resided at Extension and was working on the farm on Aug. 19th. Witness first saw the trouble about 6 o'clock when some of the buildings were on fire. Saw a big crowd of men numbering hundreds, a riotous crowd which was shooting and making a disturbance. Witness saw E. Morris and J. Gilmore on the 14 between 1:30 and 2 o'clock when witness was made a prisoner in an empty house by a crowd numbering about 100. John Anderson and Ernie Morris were among the crowd which came after witness. Anderson told witness he would have to go with the crowd dead or alive. Witness saw Mrs. Mitchell at Joe Fontana's house on Aug. 14th. Witness saw David Gilmore on Aug. 13th, Gilmore being with a crowd of twenty-five which tried to make witness quit work. Every member of the crowd was armed with the exception of one man. Witness recognized R. G. Gowland as being one of the crowd. On the 14th witness saw Robt. Taylor, Joseph Burns and Fred Marshall in the crowd which tried to run witness out of town.

In reply to Mr. Darling witness stated John Anderson and Morris were the only two who spoke to him.

Alfred Haydock, constable at Extension stated he encountered trouble about 2 o'clock. Saw a crowd gathering and witness went over to it. The crowd being witness to get out for they were going to drive every man out of Extension. A whistle was sounded and immediately a crowd of 500 rushed down upon him assaulting him. In the crowd witness recognized the two Gilmores, Isaac Greenwell, Archie Greenwell, Lewis Menzies, John Murdoch, Charles Rice, S. Fairhurst, J. Gilson and J. Sherwood. The large crowd afterwards went down to the mine when the shooting started. Witness saw houses burning on the fourteenth, but could not recognize any of the crowd as witness was too far away fearing for his life had he went any closer.

Frank Passerini informed the Court he worked in the mine and also kept a store. Early in the morning witness saw Angelo arrive in a buggy and point out to another man a number of houses which were afterwards destroyed. There were lots of property destroyed. Witness identified Geo. Bramley, Robt. Taylor, Robt. Hamilton, J. Gilmore and son as being in the mob which made witness a prisoner, witness being released up on the arrival of the soldiers. Witness lost all his store stock, estimated to be worth \$5000, the whole place being ransacked. Witness saw Steve Michak run out of the saloon and say "Now boys get your guns now is the time to use them."

F. Philo remembered Aug. 13 th saw Joe Angelo on Aug. 13th with a bunch of people which belonged to the Union. The crowd was up on the hill till 6 o'clock and after a while they came down to the mine. They started firing and burning and destroying everything around the crowd being the same one which came down the hill. Witness had all his household effects stolen or destroyed. The crowd was after witness so he ran past the superintendent's house into the big timber.

Mrs. Mary Hero informed the Court she resided at Extension and remembered the trouble on that day. She remembered seeing Fairhurst and Archie Greenwell. Witness did not look out of her house for the windows were broken and she was afraid of getting hurt. The crowd was riotous and doing much damage there also being many shots fired. In reply to Mr. Darling witness

stated she saw Fairhurst apparently directing the Nanaimo men where to go.

By the Court sworn stated she saw Mr. Fairhurst at Extension who told witness to go ahead but be sure and not tell anybody what she had seen. In reply to Mr. Darling witness stated she saw Willie Bowater referring to witness said "That is a Scab's kid."

Mrs. Cosk informed the Court she resided at Extension. Her piano and side card being broken. Witness did not recognize any of the mob as she was fleeing for her life.

Mrs. John stated she was in Extension at 7 p.m. when she saw young Bowater come out of Boban's house and go into Cunningham's and break the piano and other furniture. Witness was driven into the bush for safety during the afternoon and came out at 7 o'clock. Was positive Bowater was there for she knew him well. There was a crowd with him, the crowd setting fire to the place for witness saw the smoke.

Mrs. Jane Cowan informed the Court she resided at Extension there being trouble there on the afternoon of Aug. 13th. On the 13th she heard shooting but did not see anybody. On Thursday morning a big Italian came to the door of witness's house and Mr. Murray came, also two others but witness did not know their names. The men came to look for her husband and Murray told witness "To shut her eyes." Witness told the men to go on that she would not do anything. Witness saw Archie Greenwell break the back of one of her chickens with a rock. Saw E. Morris, Struthers, John Anderson with guns going in the direction of Shires' house. Saw a number of Italians carrying guns but witness did not know any of them.

John Johns stated there was considerable property damaged at Extension on Aug. 13th. Witness heard considerable firing and saw a mob but could not recognize any of the number. Witness was standing with a bunch which was being fired at, the crowd evidently wanting to drive the workmen away but they got badly left. The crowd numbering a couple of hundred came down armed with clubs and guns with the object of getting after the workmen. Witness saw destruction being done with axes and fire.

Fercy John gave evidence to the effect he resided at Extension on Aug. 13th. Saw a crowd coming onto the tipple witness recognizing Steve Wynosky, D. Gilmore and Bob Hamilton among the crowd.

Frank Behn had his home looted by the mob and some of his furniture destroyed, also had the wheels of his auto chopped. The crowd was an excited one, there being considerable shooting going on. Witness could not recognize any of the shooters for they were too far away. Witness saw the crowd setting fire to Michies house and his auto.

Miss Johns informed the Court she saw a crowd of six or seven come out of Bevan's house and go over to Cunningham's house. Witness saw the crowd break down the front door of Cunningham's house, then go inside and set the place on fire. Witness would not say that Bowater set fire to the house but he was in the crowd that did burn the dwelling.

Mrs. Elvardo stated she resided at Extension having left her home in the morning, going up to the ridges and coming back on Thursday evening. Witness saw Joe Angelo pointing out houses which were afterwards looted.

Mrs. White informed the Court she visited the home of a certain woman in Extension on Wednesday, the woman being in bed at the time with an infant four or five days old. Witness visited the woman's home early in the morning and again in the evening when she found the house empty, the woman having left the house. The door was broken on the hinges and witness relieved the woman had become frightened and left. Witness did not know the woman's name, it being an Italian name which she could not pronounce.

Mr. Shuretham informed the Court the woman's name was Mrs. Catherine Jelontse.

This completed the case for the Crown. Mr. Shuretham requesting a withdrawal of the charges against Pagnini, J. S. Greenwell, T. Greenwell, Arthur Jordan and N. Richardson, the request being acceded to by the Court.

Mr. Darling argued for the dismissal of the charges against Chris Pattinson, W. Bowater, Sr. S. Zwoy-

sky and S. Sherwood and after evidence had been submitted in their behalf the charges against them were withdrawn.

Those as mentioned in the opening paragraph were thereupon committed and Court adjourned to Monday morning next at 9 o'clock.

## EAST ASIATIC CHARTER

Under charter of the Danish East Asiatic Company the British steamer Lord Londale, Captain Foster, has reached San Francisco from Copenhagen and Antwerp. The Lord Londale will come north to Victoria and Vancouver about the middle of the month to complete discharging European cargo. Outward the Lord Londale has been chartered by Balfour Guthrie & Company for grain to the United Kingdom at \$38 3d. with the option of general merchandise at 42s 6d. She will load on Puget Sound or at San Francisco.

The motorship Siam, first of the type to come to the North Pacific, will leave Copenhagen next month for Victoria in the service of the Danish Asiatic line.

## SYNOPSIS OF COAL MINING REGULATIONS

Coal mining right of the Dominion in Manitoba, Saskatchewan and Alberta, the Yukon Territory, the Northwest Territories and in a portion of the Province of British Columbia, may be leased for a term of twenty-one years at an annual rental of \$1 an acre. Not more than 2,500 acres will be leased to one applicant.

Application for a lease must be made by the applicant in person to the Agent or Sub-agent in the district in which the rights applied for are situated.

In surveyed territory the land must be described by sections, or legal sub-divisions of sections, and in unsurveyed territory the tract applied for shall be staked out by the applicant himself.

Each application must be accompanied by a fee of \$5 which will be refunded if the rights applied for are not available, but not otherwise. A royalty shall be paid on the merchantable output of the mine at the rate of five cents per ton.

The person operating the mine shall furnish the Agent with sworn returns accounting for the full quantity of merchantable coal mined and pay the royalty thereon. If the coal mining rights are not being operated, such returns should be furnished at least once a year.

The lease will include the coal mining rights only, but the lessee may be permitted to purchase whatever available surface rights may be considered necessary for the working of the mine at the rate of \$10.00 an acre.

For full information application should be made to the Secretary of the Department of the Interior, Ottawa, or to any Agent or Sub-Agent of Dominion Lands.
