On motion of Mr. Robb, the said Message and Estimates were referred to the Committee of Supply.

By leave of the House, Mr. Mackenzie King (Prince Albert) moved,—That the House do now proceed to Government Notices of Motions; which was agreed to.

Government Notices of Motions being accordingly called.

Mr. Rinfret moved, That the House do go into Committee of the Whole, to-morrow, to consider the following proposed Resolution:—

That it is expedient to amend the Public Printing and Stationery Act in relation to advances authorized to be made to the King's Printer for the purchase of materials, to execute orders and requisitions and payment of wages, and to provide that the total amount of such advances shall at no time exceed the sum of seven hundred thousand dollars or such sum as may hereafter be determined, from time to time, by the Governor in Council.

Whereupon, Mr. Rinfret, a Member of the King's Privy Council, informed the House, That His Excellency the Governor General, having been informed of the subject-matter of the proposed Resolution, recommends it to the House.

Resolved, That the House do go into Committee of the Whole, to-morrow, to consider the said proposed Resolution.

Mr. Ralston moved, That the House do go into Committee of the Whole, to-morrow, to consider the following proposed Resolution:—

That it is expedient to provide for the disposition and allotment of the Canteen Funds which were accumulated during the War by certain Units of the Canadian Expeditionary Force in Canada, the Canadian Siberian Forces and by the Forces stationed at St. Lucia (British West Indies), resulting from the profits of canteens and other like institutions operated by the several Units and Formations, and for the administration of the same by the Provincial Board of Trustees appointed under The Canteen Funds Act, chapter 34 of the Statutes of 1925.

Whereupon, Mr. Ralston, a Member of the King's Privy Council, informed the House, That His Excellency the Governor General, having been informed of the subject-matter of the said proposed Resolution, recommends it to the House.

Resolved, That the House do go into Committee of the Whole, to-morrow, to consider the said proposed Resolution.

Mr. Robb moved, That the House do go into Committee of the Whole, to-morrow, to consider the following proposed Resolution:—

That the Minister of Finance be authorized to pay to the National Battlefields Commission the sum of seventy-five thousand dollars a year for a period not exceeding ten years from the first day of April, 1928, to be expended by the Commission for the purposes of and subject to the provisions of the Act respecting the National Battlefields at Quebec.

Whereupon, Mr. Robb, a Member of the King's Privy Council, informed the House, That His Excellency the Governor General, having been informed of the subject-matter of the said proposed Resolution, recommends it to the

House.

Resolved, That the House do go into Committee of the Whole, to-morrow, to consider the said proposed Resolution.
