- Proposed amendment (Mr. Diefenbaker)—To motion for third reading of Bill No. 7, An Act respecting Citizenship, Nationality, Naturalization and Status of Aliens; ruled out of order on the ground that it was irrelevant, 223. Ruling appealed and sustained (yeas 125; nays 38), 223.
- 3. Proposed amendment (Mr. Irvine)—To motion to approve Resolution to amend the British North America Act with respect to representation in the House of Commons; ruled out of order, 375.
- 4. Proposed motion of Mr. Smith (Calgary West)—To adjourn House under Standing Order 31, *re* strikes in the Steel Industry; ruled out of order on the ground that there was no urgency as required under Standing Order 31—Motion not put from the Chair, 485.
- 5.
