# TELEVISION

PROVISION FOR ALTERNATIVE SERVICE TO GREY CUP TELECAST

Mr. Robert McCleave (Halifax) moved for leave to introduce Bill No. C-238, to secure freedom of choice in television viewing.

Some hon. Members: Explain.

Mr. McCleave: Mr. Speaker, the bill requires the Board of Broadcast Governors to choose one of the two networks in Canada to telecast the Grey Cup football game. It gives the board the power to direct that stations and satellites of the other network be added so there can be the same coverage there is now, but cuts out duplication and thus brings relief to about 80 per cent of all Canadians.

Motion agreed to and bill read the first time.
