Orders for Returns

[Editor's Note: The answer referred to above is as follows:]

- 1. Preliminary results of a study of the employment of post-secondary students in the summer of 1970 were released by the Department of Manpower and Immigration on February 4, 1971. The survey was carried out at the time students registered for classes in the fall. Because of the method used, the survey did not include students who, for one reason or another, including their inability to find summer employment, did not return or proceed to post-secondary education.
- 2. The survey established that all but 10 per cent of the students had sought paid work. Of the 90 per cent who sought work, 89 per cent found employment some time during the summer.
- 3. The population of students in universities in 1969/70 is estimated by the Dominion Bureau of Statistics as 312,000
 - 4. The survey was based on written questions.
- 5. The survey was completed by approximately 17,000 students at 54 universities, community colleges and teachers colleges across Canada. It was based on a scientifically selected sample, within which the response rate averaged 75 per cent.
- 6. A full report of the survey including an outline of the method used and a copy of the questionnaire will be ready in a few weeks' time.

- Mr. McCleave: Mr. Speaker, on a question of privilege, since I have on the order paper starred question 1178 I should like to make it clear that it refers only to flood relief and not to any other kind of relief.
- Mr. Coates: Mr. Speaker, I rise on a question of privilege. Unfortunately, it is not a new question of privilege; it is one I have raised before on this particular occasion with regard to question No. 12 which stands in my name and has stood on the order paper since October 8 in this session. On the previous occasion when I rose I brought to your attention the great problem that I face as a result of not receiving a reply to this question before now. I pointed out to Your Honour that this question was on the order paper in the last session of Parliament. I have with me today the order paper for October 5, 1970, from the last session of Parliament, and I point out to you that starred question No. 1203 is exactly the same as starred question No. 12. A point I must raise, which gives me great difficulty, is that, for instance, my question No. 43 is a similar question dealing with the same subject matter but for a later period of time.

The question relates to the Jetstar which is used by the Prime Minister, and it asks specific questions about its use. The Jetstar was purchased by the government of Canada with the taxpayers' money. It is used by the Prime Minister for specific purposes. There is no argument with that. But I do believe that the information I am asking for is legitimate information. It is information which should be made available to the people of this country in view of the fact that their tax dollars are
