## MESSAGE FROM THE SENATE

PRIVILEGE

MR. MCGRATH—FAILURE OF "HANSARD" TO SHOW THAT THERE IS A MINISTER OF FISHERIES

Mr. James A. McGrath (St. John's East): Mr. Speaker, I wish to raise a question of privilege. My question of privilege deals with the failure of the government to carry out the provisions of clause 3, subclause 3, of Bill C-207, the government reorganization bill, which was passed by the House earlier in the session. This clause provides:

The Minister of the Environment is the Minister of Fisheries for Canada.

I might add that that provision was consequential upon an amendment put forward by myself and moved in the House when the bill was before us.

On Tuesday, September 14, I directed a question to the Minister of Fisheries concerning a conservation conference. This question is reported at page 7790 of Hansard and Hansard makes reference not to the Minister of Fisheries but to the Minister of the Environment. When I brought this to the attention of Hansard, I was advised that they must work from a list of the ministry provided by the government and that this list does not contain a Minister of Fisheries. I also note that the list of ministers appended to Hansard for yesterday, Wednesday, also omitted the title of Minister of Fisheries.

I realize that this may not appear to be an important point to some, but considering that it took quite a long debate to bring this very important and useful amendment about I believe there is a continuing need in Canada for a Minister of Fisheries to give this important industry the continuing attention that it so justly needs at this time. Consequently I feel that the list of the ministers supplied to Hansard is not complete as it does not contain the Minister of Fisheries. Therefore I suggest respectfully that, in accordance with the provisions of Clause 3, subclause 3, of Bill C-207, in the future Hansard should record that there is, by the law of this country, a Minister of Fisheries.

Mr. Speaker: Hon. members will agree that the point raised by the hon. member for St. John's East is one of interest and importance. I have the impression that perhaps the point which he has raised is more a question of legal interpretation, although I am not sure. As I said, the matter is one of interest and I would like to look at it. In any event, at this point the hon. member has not thought it necessary to submit a motion for the consideration of the House and of the Chair. Therefore I will consider the matter as one which has been brought to my attention, look into it and communicate with the hon. member.
