The purpose of these meetings is to explore the activities of the Quebec and the federal governments in this field and to study the meaning of the legislation passed by the National Assembly of Quebec.

**Mr. Heath Macquarrie (Hillsborough):** I should like to direct a question to the Secretary of State for External Affairs. Based upon the statement yesterday of the Canadian Ambassador to France that a vital question for Canada is whether it can establish rapport with an enlarged and more integrated European community, can the minister advise if in this urgent matter there are any special plans for early top level discussions with members of the European Economic Community?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Yes, Mr. Speaker, except that these are not plans; these are realities. We have had discussions with the members of the European Commission. We are now in the process of establishing the kind of links to which the hon. member has referred.

**Mr. Macquarrie:** May I ask the minister if he has any lack of confidence in this area in that we might be left out in the cold unless we do a little more?

**Mr. Sharp:** No, Mr. Speaker, we have a very warm relationship with the European community.
