Olson (Minister of Agriculture): Mr. Speaker, if the hon. member is talking about the receipt of applications by the Stabilization Board, may I say we certainly would like to have them as quickly as possible and in fact encouraged them to be submitted by a date several weeks ago. If he is talking about the processing of the applications after they have been received, we cannot give a set date because we must audit those applications against the receipts by plants and auction markets, and I cannot predict how long that will take.
