DEMAND FOR ASSISTANCE TO INDUSTRY—MOTION UNDER S.O. 43

Hon. James A. McGrath (St. John's East): Madam Speaker, I rise under the provisions of Standing Order 43. Last night the finance minister announced a special farm financial assistance program which provides for \$200,000,000 over the next two years to assist farmers in financial distress. Naturally, we welcome such an announcement, but at the same time we fail to understand why similar assistance was not provided for the fishing industry which employs 80,000 Canadians and forms the backbone of the economy of the Atlantic provinces. Many companies have been forced into bankruptcy and the industry still faces an uncertain future. I would therefore

That this House direct the Minister of Finance to provide immediate assistance to the fishing industry in a program similar to that which is now being offered to the agricultural industry.
