REQUEST FOR END TO CRUISE MISSILE TESTING

Ms. Pauline Jewett (New Westminster-Coquitlam): Mr. Speaker, my question is directed to the Prime Minister who will know quite well that agreeing to test the Cruise missile in Canada was one of the most controversial and unpopular decisions of the previous Liberal Government. In view of the dangers to public safety revealed in yesterday's test, and particularly in view of the new hopes for arms reduction talks in Geneva—massive reductions in arms—will the Prime Min-

ister now commit Canada to participate in the process of arms de-escalation and end Cruise missile testing in Canada?

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, it is not our view that the breaching of an agreement by Canada would contribute to the de-escalation of arms build-up in the world. As the Hon. Member knows, I will be making a statement later today indicating some practical steps which Canada takes. We think it very important, if we want to make real progress on these questions, that we focus on practical steps which can be achieved by a country like Canada.

Ms. Jewett: In a way I am glad the Minister answered because the Prime Minister does not know what to say on the issue.
