## REQUEST THAT ISSUE BE DEBATED IN PARLIAMENT

Right Hon. John N. Turner (Leader of the Opposition): Mr. Speaker, I would like to put a final question to the Deputy Prime Minister, if he can speak on behalf of the Prime Minister. The Deputy Prime Minister knows that this type of ruling is a purely discretionary decision. It does not flow from the Income Tax Act. He also knows that the Prime Minister claims to have made the final decision in the Gulf matter.

Will the Prime Minister have the final say on whether or not a tax ruling will be issued in favour of Dome Petroleum or a purchaser of Dome Petroleum? Will he undertake—I do not want to interrupt the hurried consultations on the front bench—

Mr. Mazankowski: That is a silly question.

Mr. Turner (Vancouver Quadra): "A silly question", the Deputy Prime Minister says. It is a silly question involving thousands of jobs and Canadian ownership of our oil and gas industry! Oh, a silly question?

Some Hon. Members: Oh, oh!

Some Hon. Members: Hear, hear!

Mr. Gauthier: That was a silly comment.

Mr. Turner (Vancouver Quadra): I think the Deputy Prime Minister needs the next 10 days to reflect on that particular interjection. Will he give an undertaking that before that discretionary decision is made by the Prime Minister and his Government he will bring the issue before Parliament, because the Canadian taxpayer has a right to know what has happened?

Hon. Elmer M. MacKay (Minister of National Revenue): Mr. Speaker, if the Right Hon. Leader of the Opposition would permit me, I would say to him that he knows that this kind of a ruling is made according to well established processes. A taxpayer who wishes a ruling communicates with our Department, to the Deputy Minister or to the proper official. They seek to bring themselves within the income tax law. They set out the kind of proposition they have. We have the resources of the Department of Justice who assist in this very—

Mr. Turner (Vancouver Quadra): And the Department of Finance

Mr. MacKay: We have the resources within the section in our Department as the Opposition Leader knows, having been Minister of Finance, to make a proper decision based on the law and in an arm's length fashion. He knows the way this thing works.

Mr. Turner (Vancouver Quadra): That is why I am asking.
