CANADA SCHOLARSHIPS PROGRAM

AWARDS TO 2,500 STUDENTS

Mr. Dave Nickerson (Western Arctic): Mr. Speaker, I would like to underline the importance of the Canada Scholarships Program. The Government is very pleased to honour some of Canada's best students through this innovative program. Fifty-three young Canadians have recently been in Ottawa as representatives of the 2,500 1988 Canada scholarship winners. Each student will be eligible for \$2,000 per year for a total of \$8,000 per scholar.

The Canada Scholarships Program was announced by the Prime Minister (Mr. Mulroney) last January in Toronto at the National Conference on Technology and Innovation. It will help fill the pressing need for highly qualified personnel in industry, universities, and government. Our future prosperity will be greatly enhanced by the contributions of these well trained, bright young people. As the Prime Minister stated at the University of Waterloo in March, 1987, the western world is moving toward knowledge-based economies, and Canada must move with it.

YELLOWKNIFE—APPLICATION OF NORTHERN TAX BENEFIT

Ms. Audrey McLaughlin (Yukon): Mr. Speaker, federal employees in Yellowknife, Northwest Territories, are being subjected to seeing a benefit quickly become a liability. The northern tax benefit has become a nightmare for over 600 employees owing to the Government's refusal to set the housing benefit at a fair rate. As a result, there is the clearly inequitable situation in which a federal employee in the Yukon might receive a \$600 credit in taxes as a result of the northern benefit while a Yellowknife employee receives a \$2,000 to \$3.000 liability in extra taxes.

To complicated this situation further, Treasury Board has not been deducting the appropriate tax at source and employees are now hit with owing as much as \$5,000 to \$6,000 in back taxes. So much for fairness for average families. Revenue Canada's response is "Pay up or else". Treasury Board's response is "If you don't like it, leave the North". That is exactly what is going to happen. Yellowknife employees are requesting to be transferred out and other

employees are indicating that they will refuse assignments to Yellowknife.

I challenge the Minister responsible for Revenue Canada, whose Government likes to preach tax reform, to go to Yellowknife and meet with federal employees to resolve this unjust, unfair, and inequitable situation.
