### CANADA-U.S. FREE TRADE AGREEMENT

**Mr. Dan Heap (Spadina):** Mr. Speaker, it is my honour and duty, in accordance with Standing Order 106, to present a petition signed by some 200 residents of the constituency of Spadina and nearby in Toronto. They point out that Canadian sovereignty is threatened by the proposed trade deal between the Prime Minister (Mr. Mulroney) and the President of the United States, for which the Prime Minister has no mandate.

Further, it would reduce Canada's ability to plan the programs we need for economic, social, and cultural needs, and would integrate us further into the North American defence industrial base.

Therefore, they request that Parliament make sure that there will be a debate in a national general election before this agreement is finalized.
