



Windstorm in Saskatcon

SASKATOON, Sask., July 6.-(Can. Press.)-A miniature cy-cone passed over the north end of this city, accompanied by heavy rain, about 9 o'clock yes-terday morning. A number of garages and smaller buildings were wrecked, but most of the damage was done in the neigh-borhood of the Western Canada Sawmills, a large portion of the lumber in these yards being whirled up in a vortex to a height of between one and two hundred feet before being thrown to the ground and umashed to kindling wood.
