The accused, Brigadier James Frederick Alexander LISTER, 4 Wing, Canadian Repatriation Depot, attached for all purposes to Headquarters, Canadian Repatriation Units, an officer of the Canadian Army Overseas, is charged with:

First Charge
Section 40
Army Act

WHEN ON ACTIVE SERVICE CONDUCT TO THE PREJUDICE OF GOOD ORDER AND MILITARY DISCIPLINE

in that he

in the Field in Holland, between the 15th day of August, 1945 and the 9th day of January 1946, while Chief of Staff and DA & QMG at Headquarters, Canadian Forces in the Netherlands, improperly used for his own private purposes a house, namely, Oranje Nassaulaan 58, City of Amsterdam, requisitioned for the Canadian Army for official purposes, the cost thereof being paid from public funds.

Second Charge
Section 18(4)
Army Act

WHEN ON ACTIVE SERVICE FRAUDULENTLY MISAPPLIED PUBLIC PROPERTY

in that he

in the Field in Holland, between the 15th day of August 1945 and the 9th day of January 1946, while Chief of Staff and DA & QMG at Headquarters, Canadian Forces in the Netherlands, with intent to defraud, applied to his own private use public property, to wit, a quantity of food and coal to which he was not entitled.

Third Charge

Army Act
(Alternative)

WHEN ON ACTIVE SERVICE CONDUCT TO THE PREJUDICE OF GOOD ORDER AND MILITARY DISCIPLINE

in that he

in the Field in Holland, between the 15th day of August 1945 and the 9th day of January 1946, while Chief of Staff and DA & QMG at Headquarters, Canadian Forces in the Netherlands, improperly had public property, to wit, a quantity of food and coal delivered to Oranje Nassaulaan 58, City of Amsterdam for his own private use.

Fourth Charge

WHEN ON ACTIVE SERVICE CONDUCT TO THE PREJUDICE OF GOOD ORDER AND MILITARY DISCIPLINE

in that he

in the Field in Holland, between the 15th day of August 1945 and the 3rd day of January 1946, while Chief of Staff and DA & QMG at Headquarters, Canadian Forces in the Netherlands, utilised for his own private purposes at Oranje Nassaulaan 58, City of Amsterdam, the services of Dutch civilians, to wit, Joseph WILTHAGEN, Staff Manager; Anton OUVERMARS, Cook; J Frie KEENIE, Chambermaid; W. SOUWER, Handyman; who were paid out of public funds.
