When arrested Moir was busy cutting thistles. He still wore his asylum clothes. He had been engaged to do farm work at \$23 per month and his board.

M'CULLOUGH PLEADS GUILTY HELPED MOIR TO ESCAPE DANING RUBBI

Another Attendant of Hamilton Insane Acylum Denies the Charge-Penalty for the Offense May Be Made Seven Years.

Hamilton, Aug. 22.—At the police court this morning, Fred Mc-Cullough, an attendant at the asylum, pleaded guilty to a charge of assisting in the escape of Moir and Taggart from the institution a week ago today.

Monteith Trapnell, the other attendant, who was arrested the same charge, pleaded not guilty and elected to be tried at higher court. Both men were remanded. The maximum penalty for the offence is seven years.
