Washington, Jan. 9. - The naval tug Sonoma, which left Hampton Roads with the repair ship Panther for Guantanamo, Jan. 3, arrived at the latter port at 1 o'clock this morning. MOTHER AND SIX CHILDREN FOUND STARVING AND COLD

Inspector Sanders Located a Case of the Most Dire Destitution in the South End of the City Today-Woman Is

Inspector Joseph Sanders, of the Charities Organization, investigated a case of the most pitiful destitution in the south end of the city this morning, where he discovered a widow, with her six young children, practically without food or fuel. There had been no fire in the place for a considerable time, and with the temperature hovering close to the zero mark the case was particularly pathetic.

The mother had worked at different places about the city, but of late had been unable to find employment. None of the children are old enough to earn anything, and have been absolutely dependent upon the mother's resources.

The Charities Organization has provided for the seven members of the family for the present

Inspector Sanders has commented upon the fact that there is little actual poverty in London this year, and there is plenty of work all who seriously care to obtain employment. Only three men, all strangers in the city, have applied to him for help in securing

work this winter, and these were readily accommodated. The majority of those who have applied for assistance have reduced to their unfortunate positions because of illness, but even such applications are fewer than in former years.

DUCHESS IN PAIN DURING THE NIGHT: MAY BE OPERATION

Gov.-General's Wife in Montreal Hospital Suffering From Peritonitis.

DOCTOR'S BULLETIN CAUSES ANXIETY

Distinguished Patient Is Today More Comfortable, According to Latest Report.

[Canadian Press. Montreal, Jan. 9.—That the Duchess of Connaught, who was rushed to the Royal Victoria Hospital here from Ottawa, where her royal highness was taken ill with peritonitis, had not passed a good night, but was more comfortable this morning, was the report obtained from the doctors attending the distinguished patient this morning.

The following bulletin was issued at

11:45 a.m.: "Her Royal Highness the Duchess of connaught did not pass a very good night, but was restless and complained of considerable pain. This morning. lowever, the duchess' condition showed improvement (Signed) E. S. WORTHINGTON.

"A. E. GARROW, M.D., "W. W. CHIPMAN, M.D." The announcement that the duchess had passed a bad night caused much apprehension in the city, and the newsapers were besleged by inquiries.

A rumor was started that the duchess was to be operated on this afternoon, but no confirmation of this statement could be secured anywhere. The doctors and those in attendance on the duchess absolutely decline to

give out information except in the form of official bulletins. The quarters in the Royal Victoria Hospital where the duchess' room is situated, is most rigidly guarded so as to prevent her attendants from being interrogated by the newspapermen and sympathizers who visited the hospital his morning.

It was learned from Arthur Sladen, the secretary to the Duke of Connaught, that her royal highness slept most of the morning. It is understood that another consultation of doctors was held this afternoon, and the bulletin, which it is expected will give the result of the conference, is awaited with the utmost



Drop Food Tax Platforms

London, Thursday, Jan. 9.—Tariff reform, so far as it involves the taxing of food, is on the eve of final disappearance as a plank in the Unionist policy, according to a statement published in this morning's Chronicle.

A representative meeting of Unionists was held in the House of Commons yesterday, with the object of healing, if possible, the dissensions in the Unionist party created by the recent proposal to impose taxes on food imported into the British Isles, and restoring the unity of the party.

A memorial was drafted, it is stated, and addressed to Andrew Bonar Law, leader of the Opposition in the House of Commons, advocating the policy of abandoning the food taxes at the next general elections.

According to the authority quoted the memorial was signed a majority of the Unionist members. The Unionist newspapers make no mention of the meeting in this morning's issue.



Militant Suffragettes Heavily Punished for Destroying the Mails.

ONE LADY IS A CRIPPLE

Letter Boxes Throughout London Were Damaged By Means of Acids, Varnish and Ink.

London, Jan. 9 .- Long sentences were passed today on two of the militant suffragettes, many of whom in recent months have engaged in a campaign of destruction of the mails, May Billinghurst and Louisa Gay, two of BEFORE LEGISLATURE the first to be arrested in connection with these outrages, were brought up for trial at the Old Balley today and condemned to eight months' imprisonment each

May Billinghurst, who is a cripple, and is unable to get about except on a tricycle, already has been imprisoned on several occasions in connection with

the suffrage campaign. The evidence given today showed that letter boxes throughout the centre and the West End of London had been damaged, together with their contents by means of acids, sticky, fluids of various kinds, varnish, ink, and, in some cases, inflammable materials, such as rage soaked in lamp oil, had been inserted through the slits in the boxes for the admission of the mail. Many valuable documents had been destroyed in this way. These included money orders, contracts, checks and bank notes.
