EXPORTATION OF WOOL.

Mr. TOBIN:

Is it the intention of the Government to place an embargo on the exportation of wood from Canada?

Mr. REID: Canadian wool is permitted to be exported from Canada to foreign destinations only under license issued from time to time and the issue of licenses may be suspended at any time when conditions so require.

1. Is Mr. Perkins Bull, who is running a convalescent home in England, the same Mr. Perkins Bull, lawyer and real estate dealer in Toronto?

Mr. BOULAY:

What sums have been paid each year to Judge L. R. Roy of the Supreme Court of Quebec, for travelling expenses, since the date of his appointment to the 31st of March, 1917?

Mr. DOHERTY: The Honourable Mr. Justice Roy was appointed to the Superior Court of Quebec on 17th November, 1909, since which date he has been paid the following sums for travelling allowance: In 1909-10, \$42; 1910-11, \$535; 1911-12, \$196.40; 1912-13, \$429.30; 1913-14, \$1,145.05; 1914-15, \$1,318.70; 1915-16, \$1,576.30; 1916-17, \$656.75.

Mr. REID: I would ask the hon. member to drop this motion for the reason that the Deputy Minister of the Naval Service advises me that under present conditions it is not considered advisable to bring down the information asked for in the proposed motion for a return giving a list of vessels in the service of the Government under the terms of the Canadian Naval Act.
