How many employees of the harbour commission of Quebec were dismissed between August 1, 1930, and October 14, 1935?

Mr. RINFRET: Three hundred and eighty, exclusive of men working on the contract at Wolfe's Cove terminals and who were supplied by the Quebec harbour commissioners. In August, 1930, the average number employed on this contract was 774. By September 17, 1930, the force had been reduced to 106. Staff was then gradually increased to 726 by September 30. By October 15 this number had been increased to 1,246.
