Mr. Regier: I wonder if the minister would be able to say whether a report is also going to be made as to the application of section 62 to other religious organizations.

Mr. Regier: Mr. Speaker, on a point of order, this question of mine is as the result of a news item, a copy of which the minister has. It is a new development. I am only asking the minister whether the efforts now being undertaken will also apply to other religious organizations, and the minister has not replied.

Mr. Nowlan: Mr. Speaker, studies in my department are being made from time to time of all matters with respect to the application of our taxation laws.

Mr. Argue: A supplementary question. Is this particular study being made in regard to all religious organizations or just one?

Mr. Nowlan: I have answered that question.
