Inquiries of the Ministry

Farha, Canadian citizens of Lebanese extraction, contended that they were called in on the instructions of the Lebanese ambassador, M. Edmond Khayat, and intimidated with reference to their political activities with the threat of some misfortune or ill treatment being meted out to their families which are still in Lebanon? I want to ask the minister whether he has taken any action with respect to this matter, if the ambassador in question has been called in, and if any action has been taken by the government to ask the government of Lebanon to recall him if the facts in this article are correct.

Hon. Paul Martin (Secretary of State for External Affairs): Mr. Speaker, the various press reports on this subject were called to my attention and I have received a telegram containing certain allegations in very general terms. This telegram is now being examined by the department in the light of normal diplomatic practice, and I have given instructions that it be discussed with the Lebanese embassy here in Ottawa. This is the usual practice. I arrived back just last night and have not had a report of these discussions. Perhaps before the day is out I may be in a position to say something further in this connection. Just before I left I gave instructions that this matter was to be discussed forthwith with the Lebanese ambassador, because on the surface the circumstances were certainly of an order that called for explanation.

Mr. Douglas: A supplementary question, Mr. Speaker. Could I ask the Secretary of State for External Affairs who the telegram was from and whether any of the officials of his department have interviewed either of the gentlemen in question in order to verify the newspaper reports of the accusations which they made regarding the Lebanese ambassador?

Mr. Martin (Essex East): I cannot say who the telegram was from, Mr. Speaker. I saw it, but I forget who it was from. With regard to the last part of the hon. member's question, I will make inquiries about that matter.
