REQUEST FOR ASSURANCE MOVEMENT OF GRAIN NOT IMPAIRED BY RAIL STRIKE

Mr. Don Mazankowski (Vegreville): Mr. Speaker, I wish to direct a question to the Minister of Justice as the minister in charge of the Canadian Wheat Board. It arises out of a question posed by the hon. member for St. John's East regarding the impending rail strike. Can he advise the House if he has had any discussions with the Minister of Labour and the Minister of Transport regarding the effects which a strike would have on the movement of grain, and can he assure the House that adequate steps will be taken by the government to ensure that the delivery and movement of grain will not be impaired by reason of a strike?

Hon. Otto E. Lang (Minister of Justice): Yes, we have had discussions, Mr. Speaker. I would not speculate on the impact of any hypothetical event except to assure the hon. member that, as always, we will do everything we can to see that the farmers of the country are protected.

# ELECTORAL BOUNDARIES READJUSTMENT ACT

AMENDMENT TO SUSPEND OPERATION OF ACT

The House proceeded to the consideration of Bill C-208, to suspend the operation of the Electoral Boundaries Readjustment Act, as reported (without amendment) from the Standing Committee on Privileges and Elections.

Mr. Don Blenkarn (Peel South) moved:

That Bill C-208, An Act to suspend the operation of the Electoral Boundaries Readjustment Act, be amended in clause 4 by deleting the words "1st day of January, 1975" where they appear on lines 4, 8 and 9 at page 2 and by substituting therefor the words "1st day of July, 1974".

Mr. Speaker: Would the hon. member indicate the seconder of the motion?

Mr. Blenkarn: The hon. member for Victoria (Mr. McKinnon).

Mr. Speaker: There may be some difficulty in this respect. The hon, member is not in his seat.

Mr. Bell: Then I will second it.

Mr. Speaker: Is it the pleasure of the House to adopt the said motion?

Mr. Blenkarn: Mr. Speaker, I want to say a few things, prior to getting into detail on the amendment, to indicate why the House should adopt the amendment. It took a long time for Parliament to get around to passing the Electoral Boundaries Re-adjustment Act which was finally passed in the 1964-1965 session, and became chapter 31 of the statutes of that year. It set up a non-partisan commission. It strikes me that, if anything is going to be done in terms of the re-adjustment of electoral boundaries, the concept of a non-partisan commission would have to be considered by the House.
