### **AGRICULTURE**

AID TO FARMERS FACING FORECLOSURE

Mr. Bud Bradley (Haldimand-Norfolk): Madam Speaker, my question is directed to the Prime Minister. The Minister of Finance requested that individual cases be referred to when discussing farm bankruptcies in this House, and I would like to refer to a case from my constituency pertaining to a couple who have farmed for 40 years, paid off five bank mortgages during that period, raised nine children, some of whom have gone into agriculture, and were encouraged by a local lending organization to expand their operation in 1973.

In the last year and a half, Madam Speaker, this family have been faced with all their operating funds being cut off by their bank; their son has had his farm foreclosed by his bank; and now this family have been given 30 days' notice to repay their loan or face foreclosure. This leads to this couple, now of retirement age, selling their farm and their retirement home in Delhi, Ontario, to meet these demands. My question to the Prime Minister is this: what do you propose to do to help this couple and others like them in agriculture in Canada today?

Some hon. Members: Hear, hear!

Right Hon. P. E. Trudeau (Prime Minister): Madam Speaker, I remember the Minister of Finance made an offer to the hon. member for Kingston and the Islands, and I make the same offer to the hon. member. If he will forward the name to the minister he will see what he can do in talking to the banks about it.

An hon. Member: Can they all do that?

#### SMALL BUSINESS DEVELOPMENT BOND PROGRAM

Mr. Bud Bradley (Haldimand-Norfolk): Madam Speaker, I am sure my colleagues on this side will forward all their letters again to the minister, as this letter has been forwarded both to the Minister of Agriculture and the Minister of Finance without response. I would think, Madam Speaker, when a member of this House rises to ask a specific question appealing a case for some of his constituents to the Prime Minister, that possibly we could have an answer of substance.

My supplementary is that the Prime Minister will know that the Minister of Agriculture stated some three weeks ago that the small business development bond would be extended to include unincorporated small business and farms. Can he tell us if this is a fact, is it a reality, is it happening, or is it another Whelan pie-in-the sky statement?

Right Hon. P. E. Trudeau (Prime Minister): Madam Speaker, the hon. member expresses disappointment that he did not get an answer of substance. I think he is realistic enough to know that I could not possibly, without advance notice, know about a particular case of a particular family in one part of Canada and their troubles with the bank. That is why the Minister of Finance made the suggestion that if a particular case were drawn to his attention he would undertake to let the banks understand that this case had been drawn to his attention, and would ask them to exercise the kind of compassion that he talked to them about when he met them, with his colleagues, two weeks ago here in Ottawa.

As to the specific question of the hon. member, I think the Minister of Agriculture indicated this kind of consideration was one which had been drawn to the government's attention and to that of the minister, and that if he had any answer to it he would be making it known in this House.
