## CANADIAN NATIONAL RAILWAYS

Question No. 28—Mr. Cossitt:

- 1. With reference to the answer to question No. 253 of the Third Session of the Thirtieth Parliament which states in part "It is not the practice of Canadian National to disclose the names of persons or firms submitting tenders for the supply of services", on what date was this practice established and (a) who established it (b) for what reason?
- 2. Since Canadian National Railways is owned by the taxpayers of Canada, will the government institute an immediate policy of making public any information legitimately requested in the House of Commons about its operations and, if not, for what reason?
- 3. With further reference to the answer to question No. 253 of the Third Session of the Thirtieth Parliament which states in part "The amount of gross revenue paid by Blue Line Taxi Company Limited to the Crown is considered confidential to the parties involved during the term of the agreement" (a) who considers this to be confidential and for what reason (b) what are all the reasons the government permits any publicly-owned operation to keep its expenditures confidential (c) will the government now make this information public?
- Mr. D. M. Collenette (Parliamentary Secretary to President of the Privy Council): I am informed by the Department of Transport, the management of the Canadian National Railways and the Prime Minister's and Privy Council offices as follows:
- 1. The cited practice is based on the needs and customs of the competitive commercial environment in which CN operates, including respect for confidentiality regarding the affairs of others proposing to contract with it. The time when that specific practice was adopted is unknown but doubtless predates the tenures of office of the present members of the board of directors and senior management officers of CN. The reason may be taken to be the protection of CN's ability to negotiate or call tenders advantageously.
- 2. Because Canadian National operates in a commercial and competitive environment it is not deemed desirable to impose upon that corporation disclosure policy which would place it at a disadvantage with its competitors.
- 3. Blue Line Taxi Company Ltd.'s contract with the Department of Transport for the provision of taxi service at Ottawa International Airport was a negotiated agreement dating from 1969. This agreement was terminated on April 30, 1980.
