One of the most interesting and best-attended meetings that the Historical Society has ever had was held last night in the Normal School, when Major Sheppard, of Queenston, gave a stirring account of "Three Historic Days on the Niagara Frontier."

Major Sheppard has lived all his life in the vicinity of the decisive battles of the war of 1812, and in his youth was acquainted with many of the veterans, from whom he gathered important details.

The American Attack.
After a short account of the causes of the war, the forces available, and the plan of campaign, Major Sheppard told of the attack of the Americans by way of Lewiston on June 17, 1812.

General Brock, he said, was a very brave man, although at times, rash, and his attempt to recover Queenston Heights was criticised by many.

However, letters that have been found since show that it was principally with the object of recovering the guns that the attack was made, and this in a soldier's eyes was second only in importance to saving the colors.

Brock Killed.
Brock was twice struck while ascending the hill the second time, falling, and dying shortly afterwards.

Lieutenant FitzGibbon, who took command of a small party, proved so harassing to the Americans that on the night following the battle they sent a force to capture him.
