### IN THE LEGISLATURE AT FREDERICTON

Commission Bill is Introduced—Mr. Bentley in Spirited Speech

Fredericton, N. B., March 8.—For the first time within the memory of the present members of the legislature the house will meet this year on the first Saturday of the session. When business presses near the close of a session Saturday sittings are sometimes held, but this has never been done during the debate upon the address. Premier Fleming would not heed the request of the opposition leader that the usual custom should be followed, and consequently the debate upon the address will be continued tomorrow.

A. F. Bentley, this afternoon, in reply to Premier Fleming, not only surprised his friends by his clear-cut criticism of the statements of the leader of the government, but evidently disturbed that gentleman, if this frequent interruption of the member for St. John county were any indication of his frame of mind.

Mr. Fleming asked for leave of absence for Dr. McInnes on account of illness; also for Mr. Baker for two weeks on the same grounds.

Hon. Mr. Fleming submitted the report of the committee to appoint standing committees.

Mr. Copp asked for leave of absence for Mr. Burns until Tuesday next.

Hon. Mr. Fleming submitted the annual report of the commissioners of New Brunswick Coal & Railway; also the annual report of crown land department.

Mr. Sweeney asked for leave of absence for Mr. Robinson until Tuesday next.

Mr. Copp gave notice of inquiry regarding immigrants from England in Westmorland county; the amounts paid since the close of the fiscal year on wharves and bridges in Queens county, and a statement as to expenditures by highway boards.

Mr. Bentley gave notice of inquiry regarding repairs to the Suspension bridge.

Hon. Mr. Maxwell presented a petition in favor of a bill to give the city of St. John better control of electric wires in the city.

Mr. Baxter presented a petition in favor of a bill to provide for the government of St. John by an elective commission.

Mr. Wilson presented a petition in favor of a bill to confirm an agreement between his majesty, the city of St. John and the Central Railway.

Mr. Baxter presented a petition in favor of a bill to authorize the city and county of St. John to expropriate private lands.

Mr. Upham gave notice of inquiry regarding repairs to the Woodstock bridge.

Mr. LeBlond gave notice of inquiry regarding the amounts paid for public works in Queens county since the close of fiscal year.

The Canada-Cuba item was passed.

A surplus of \$88,000,000 over all expenditures on revenue account is promised in the present fiscal year. The revenue for the eleven months to March 1 is more than \$220,000,000 and with the present month's will amount to about \$138,000,000 or \$18,000,000 in excess of last year. Expenditure has shown a comparatively small increase.

Five of Mr. Borden's Nationalist allies stood up last night in parliament and in defiance of the Conservative leader voted for Mr. Mondon's amendment to the Manitoba boundary bill providing for separate schools. The amendment provided for the addition of a clause to the effect that "Nothing in this act shall affect prejudicially in any way the school rights of minorities, Protestant or Catholic, as they may now exist in the territory to be added to Manitoba. The amendment was lost.

Ottawa, March 8.—Just prior to the adjournment of the common session, Hon. E. F. Power, who was leading the house, warned the members that proposition was expected to take place before Easter, and asked for the co-operation of the opposition members in facilitating business.

Premier Borden will move on Monday that morning sitting of the house begin on Thursday next, with Saturday session as well. Progress is expected on March 30.

## HAS AROUSED MUCH INTEREST AMONG JEWS IN TURKEY

### Resignation of Chief Rabbi of Sephardic Community Opens up Question of French and German Influence

(Times Special Correspondence.)

Constantinople Feb. 12.—Considerable excitement prevails at the present among the Jews in Turkey owing to the unexpected resignation of the chief rabbi of the Sephardic community, Haim Nahum Effendi.

The occasion of the resignation was a dispute between the chief rabbi and the lay council, or consistory, on the question of the formal extension to the Ashkenazim, or Jews from Eastern Europe, of the privileges enjoyed in Turkey by the Sephardim, or Sephardic Jews.

The lay council had adopted a scheme by which the Ashkenazim were to be incorporated in the Sephardic community as a kind of sub-community, possessing certain autonomous rights. The chief rabbi was strongly opposed to this scheme, and made its adoption a ground for handing in his resignation. A number of technical points have arisen and are exciting debate, and the government has not yet accepted the resignation of the chief rabbi.

In view, however, of the acute character which the conflict between Haim Nahum Effendi and the council has assumed, there seems to be no doubt that the government will ultimately consent to the election of a successor. Apparently the resignation of the chief rabbi has served to reveal in a very curious manner the play of international rivalries among the Ottoman Jews. A powerful Jewish organization, the "Alliance Israelite Universelle," which has its headquarters in Paris, has for many years contributed large sums towards the establishment and maintenance of Jewish schools in Turkey. Recently complaints have been made against this body on the ground that it had assumed an exclusively French character and was devoting all its energies to the promotion of French national interests in the east. French is employed as the language of instruction in the alliance schools, and efforts are made to counteract German influence.

Haim Nahum Effendi, who had received a French education, was a strong supporter of the alliance. The present lay council has a distinctly Jewish national character, and resents the subjugation in the work of the alliance of Jewish French national language, and in the north Jewish national language, and in Palestine of the empire Turkish, and in Palestine

Arabic. In this way, it affirms, Jewish children will be far better equipped than under the present system for serving their community in the country of their birth.

An organ which supports the lay council declares: "Let the German and the French struggle, let the German Jews and the French Jews and them in this struggle, if they will. That is their affair. But we who are neither German nor French but Ottoman Jews, have no desire to be involved in this struggle. We do not wish to be made the sport of Franco-German rivalry and to be placed between the hammer and the anvil."
