REQUEST FOR STATEMENT OUTLINING NEW GOVERNMENT POLICIES

Hon. Michael Wilson (Etobicoke Centre): Madam Speaker, my question is for the Minister of Finance. It concerns today's inflation figures which show that Canadians are suffering all the grief from the minister's policy but are getting none of the relief that he has been promising for the last 12 months. The anti-inflation policy of the government is simply not working. We are stuck at the 11 per cent to 12 per cent inflation rate. Hundreds of thousands of Canadians are losing their jobs because of the minister's policies. Thousands of businesses and farms are being destroyed. The confidence level of the Canadian people has been completely shattered by the government. Canadians are desperate. Will the minister give a commitment today to the people of Canada to make a statement outlining some new economic policies before the middle of June?

Hon. Allan J. MacEachen (Deputy Prime Minister and Minister of Finance): Madam Speaker, I think the hon. member ought to have acknowledged that there has been a drop in the year-to-year inflation rate. It is the lowest year-to-year increase for 16 months. I believe that is something which ought to be acknowledged. The peak inflation rate for this country was 13 per cent which occurred in July, 1981, I believe. The rate has dropped, and I think the hon. member ought to acknowledge that year-to-year drop recorded in today's statistics. It is a hopeful note. As well the month-to-month increase is the lowest since last September.

The hon. member, in dealing with the very serious problem of inflation, which is undoubtedly serious, should acknowledge at least that there has been a continuing downward trend, not only on a month-to-month basis, but on a year-to-year basis.

Mr. Wilson: Madam Speaker, the minister did not answer my question again. I am getting used to that, however. He never answers questions. But the minister should also acknowledge the fact that in the United States over the same period we have seen the inflation rate drop from about the same level to the current level of approximately 6.5 per cent. Clearly things are not working here in Canada, and we are suffering the same pain and the same problems as they are in the United States, without any of the benefits.
