## HAZARDS TO NAVIGATION—MOTION UNDER S.O. 43

The possibility of collision at high vehicle transit periods across bridges presents the government and the people of Canada with not only a legal but, as well, a definite moral obligation to take those measures immediately which are necessary to put fendering in place so that such incidents will not, in fact, unnecessarily cause the loss of lives at peak traffic periods.
