- 15. Resolved, That a sum not exceeding Twenty-one thousand eight hundred and forty-five dollars be granted to Her Majesty, to pay salaries of Dominion Lands and Crown Timber Agents, for the year ending 30th June, 1897.
- 16. Resolved, That a sum not exceeding Forty thousand and seventy-eight dollars and seventy-five cents be granted to Her Majesty, for salaries of Clerks in Outside Service, Forest Rangers and Intelligence Officers, for the year ending 30th June, 1897.
- 17. Resolved, That a sum not exceeding Thirty thousand four hundred and sixty-six dollars and twenty-five cents be granted to Her Majesty, for travelling expenses of Inspector of Agencies, Homestead Inspectors, and Superintendent of Mines, Land Board, Dominion Lands and Crown Timber Agents and at Head Office, removal expenses, &c., and stationery and printing, for the year ending 30th June, 1897.
- 18. Resolved, That a sum not exceeding Seven hundred dollars be granted to Her Majesty, to pay members of the Board of Examiners of Dominion Land Surveyors, stationery, rent of rooms and contingent expenses of the Board (the authority required by the Civil Service Act is hereby given for paying out of this vote such sums as may be required to pay for services of members of the Board who are also members of the Civil Service), for the year ending 30th June 1897.
- 19. Resolved, That a sum not exceeding Four thousand dollars be granted to Her Majesty. (o pay salaries of extra clerks at Head Office, Ottawa, advertising, copying, &c., for the year ending 30th June, 1897.
- 20. Resolved, That a sum not exceeding Seven hundred and thirty-two dollars be granted to Her Majesty, to provide for the salary of one carpenter, for the year ending 30th June 1897.
- 21. Resolved, That a sum not exceeding Seventy-five thousand dollars be granted to Her Majesty, to provide for the amount required for surveys, examination of survey returns, printing of plans, &c., for the year ending 30th June, 1897.

The said Resolutions being read a second time, were agreed to.

Mr. Brodeur reported from the Committee of Supply, several Resolutions : which were read, as follow:—

- 3. Resolved, That a sum not exceeding Three thousand one hundred dollars be granted to Her Majesty, for Carillon and Grenville Canal—To build boom piers, and store, for the year ending 30th June, 1897.
- 4. Resolved, That a sum not exceeding Five hundred dollars be granted to Her Majesty, for Trent Canal—To build a fishway at Lindsay, for the year ending 30th June, 1897.
- 5. Resolved, That a sum not exceeding Twenty-seven thousand five hundred dollars be granted to Her Majesty, for Farran's Point Canal—To complete dredging of prism to original dimensions, \$3,500; Towards extending the pier at upper entrance and dredging channel through Point Avoyon to slack water in Empey's Bay to secure 9 feet of water for upward bound vessels, \$20,000; Repairs to glance pier and lock (Revote \$500), \$4,000, for the year ending 30th June, 1897.
- 6. Resolved, That a sum not exceeding Twenty three thousand dollars be granted to Her Majesty, for Rapide Plat Canal Lowering mitre sills, lower recess lock No. 23, and repairing foundations of breast and upper recess, \$19,000; Gate lifter, \$4,000, for the year ending 30th June, 1897.
- 7. Resolved, That a sum not exceeding Fourteen thousand dollars be granted to Her Majesty, for Galops Canal—Dredging prism where required to original dimensions, \$10,000: New gates lower recess lock No. 26 (Revote), \$4,000, for the year ending 30th June, 1897.
