Final settlement of British mine conditions, according to City Clerk Sam Baker, himself a one-time mine worker at 10 cents per day, depends upon a reduction of capital profits and a readjustment of hours and wages of the miners.

German and French coal is selling more cheaply than Welsh coal, and consequently the mines have been operated on only a part-time basis and the men have not had sufficient vages on which to take care of their
