Bill No. 5, An Act to amend The Canadian Wheat Board Act, 1935 (Mr. Howe)—1st R., 48. 2nd R. moved, 153. Amendment (Mr. Ross, Souris)—That Bill be not now read the second time, but that further consideration be deferred until this House has had an opportunity to record its opinion *re* Government's decision with respect to settlement of the five-year wheat pool, etc., moved, 153. Subamendment (Mr. Wright). It being the opinion of this House that consideration should be given to a final payment of twenty-five cents per bushel, moved, 154. Debate adjourned, 154. Motion for House in Committee of the Whole, moved and agreed to, after debate, 231. Resolution adopted, 231. Bill No. 188, Mr. Winters, An Act to amend the Yukon Act; 1st R., 231. 2nd R., 238.
