FOREIGN EXCHANGE—INTEREST AND DIVIDENDS
PAID TO NON-RESIDENTS

Mr. HARRIS (Danforth):

What amount of United States exchange was provided by Canada in each of the years 1938, 1939 and 1940 for the payment of—(a) interest on investments in Canada held by investors outside of Canada; (b) dividends earned in Canada and paid to non-residents?

Mr. MacKINNON (Edmonton West):

(a) Interest payments in terms of Canadian dollars on Canadian bonds and debentures held by non-residents:

Total to non-residents—1938, \$139 million; 1939, \$136 million; 1940, not yet available.

To residents of the United States—1938, \$84 million; 1939, \$84 million; 1940, not yet available.

(b) Dividend payments in terms of Canadian dollars paid to non-residents by Canadian companies:

Total to non-residents—1938, \$176 million; 1939, \$174 million; 1940, not yet available.

To residents of the United States—1938, \$141 million; 1939, \$138 million; 1940, not yet available.
