But if one went to a bank for a loan it was just about necessary to put gold on the counter as a guarantee against anything one sought to borrow. Yet not everyone was so unfortunate. I can remember that one of the Japanese camps burnt down, and within 20 days, a bank manager I knew told me, they received a cheque from the Japanese government for \$80,000 to help them get started again. That is what I mean when I talk about assisting small operators.

I lived for some years in the United States, and to this day in the United States a small operator can raise sufficient money from the banks to purchase a business, providing the business, after investigation by the banks, seems to be a good one, and provided the man is honest and experienced. I have known loans of up to \$75,000 being made to a man who knew his business, in this case the hotel
